LAI Continues to Go Global

LAI held another successful Board meeting and Land Economics Weekend in Madrid from October 15 to 17.

The Madrid Chapter members were excellent hosts and put on display the best of Madrid. We learned that the Spanish economy has finally reached bottom and the trends for employment and development are now turning positive.

Repurposing of buildings is nothing new in Spain, they have been redeveloping and repurposing buildings for more than 2,000 years, since the time of the Romans. We visited the old post office which has been converted as the new City Hall with extensive public spaces. We also visited the Real Madrid football stadium which is being expanded with the addition of 15,000 seats and a high end shopping complex and hotel. Real Madrid was the team of the century for the 20th Century. We also visited the home of Santander Bank, a complex so large it is call Santander City.

Our international growth was highlighted by the approval of the LAI AUM Chapter in the State of Maharashtra, India. The Chapter's territory includes the cities of Mumbai and Pune.

The UAE Chapter in Abu Dhabi held their inaugural meeting October 12th, just before the LAI conference and added 19 new members. The UAE Chapter is off to a great start.

Any LAI member with an interest in providing services or developing in the United Arab Emirates or India should contact members of these new LAI Chapters. These areas of the world are definitely in need of the land use skills of our members.

After I started my term as LAI President last October, I visited China for three weeks. I learned about their modernization plans and saw the results of those plans in the development of Shanghai and the construction of the Three Gorges Dam.

This year my travels in Spain included Madrid, Sevilla, Grenada, Cordova, Cadiz, and Barcelona. Redevelopment and repurposing examples are everywhere. I was particularly struck by the redevelopment of Barcelona's waterfront from an industrial wasteland to thriving waterfront complex of hotels, restaurants, parkways and beaches as part of and following the 1992 Olympics.

The need for our skills as land use professionals has been around for centuries and will continue on for centuries. As LAI expands internationally, our members will help influence the best practices in land development and redevelopment in our local communities and globally. What an exciting field of work to be a part of.

in the conduct of the affairs of your Society.

In 2012, more or less, the Board constituted an ad hoc 'Governance Committee' in Hawaii to review, among other directives, " such other matters as may be of general interest to the Society".

Included in the other matters, the Governance Committee recommended (and the Board directed) that the process of conducting the Biennial Elections of the LAI Executive Committee be the subject of the broadest possible canvass for candidates from local Chapter memberships. The direction received by the LAI Nominating Committee was that not just sitting or past Board of Governors members and Nominating Committee identified candidates be considered, but that any worthy candidate presented through or by a member, be considered.

The recommendation of the Governance Committee is a further recognition of fundamental support for the principle of representative democracy, albeit within the limited institutional management structure of LAI.

Names are requested to serve on the 2015 LAI Nominating Committee and recommendations are requested of those active members of local Chapters of the Society who are prepared to serve on the 2015-17 LAI Executive Committee.

CHAPTER CORNER

Vancouver

Vancouver, like other Canadian cities, is struggling to fund new transit investments to keep pace with growth. Greg Moore, Mayor of Port Coquitlam and Chair of Metro

Vancouver, spoke on behalf of the Regional Mayor's Council on transportation at the September 17, Vancouver Chapter meeting.

The Mayors' Council, representing 23 local elected governments in Metro Vancouver, has developed an action plan for transportation that will protect the regional economy, environment, health and quality of life and serve an additional million residents over the next 30 years.

Since current revenue sources are not keeping pace with a growing population and even faster growing demand for transit two new funding sources are being considered:

- Near term: Return \$250 million of BC Carbon Tax revenues (from greenhouse gas emissions) collected by the provincial (state) government from Metro Vancouver to the region to fund transportation.
- Longer term: Staged introduction of mobility pricing on the road network to
 implement a more consistent region-wide approach to pricing road usage.
 Congestion charging or road pricing is used in a variety of cities. Some, such as
 Stockholm, have embraced road pricing. Others, such as Gothenburg, have
 recently just seen residents reject a road pricing referendum. Mayor Moore and
 Members discussed the challenge of funding transit and the feasibility of a road
 pricing referendum.

Mr. Baker is chairman of the board and chief executive officer of Ecolab Inc. With annualized sales of more than \$12 billion, Ecolab today is the global leader in water, hygiene and energy technologies and services that provide and protect clean water, safe food, abundant energy and healthy environments. Baker began his career with Ecolab in 1989, following seven years at Procter & Gamble. At Ecolab, he has held key roles in marketing, sales and general management in both the U.S. and Europe, and leadership positions including vice president and general manager of Kay, a wholly owned subsidiary of Ecolab, senior vice president of the Institutional Sector; and president and chief operating officer of Ecolab. Baker was named CEO in 2006 and chairman of the board in 2011.

September 17 Luncheon Program
Temecula Promenade Case Study

The Promenade shopping center located in Temecula is a wonderful case study in the design and management of retail development. Originally conceived by Forrest City in 1999, this shopping center was comprised of a traditional indoor shopping boulevard, 5 anchor tenants, and a standalone cinema with some outdoor space connecting it to the

main structure. The original vendors were selected based on the entry level home market that surrounded the area.

In 1999 the average household income in Temecula was \$50,000. By 2007 it has grown to almost \$90,000. This increase in household income was accompanied by a change in shopping preferences that forced the Promenade's developers to consider substantial renovation to keep relevant in the fickle world of retail. This renovation involved trading valuable surface parking for additional outdoor shopping areas that could help attract higher end retail establishments and complete the pedestrian loop created by the original indoor corridors. This tradeoff was accomplished by building parking structures on either side of the new outdoor shopping area, thus creating a revitalized front door for the Promenade that populated by high end retail. In order to carry the outside retail experience indoors, the traditional entrance area was replaced with a floor to ceiling glass system that allowed the indoor and outdoor to blend seamlessly. In hard numbers the economic effect was an increase in sales revenues of over \$150/SF realized by the tenants.

Even though this renovation is recently completed, Forrest City is already looking to the future to see how they can improve the retail experience and increase the value of their development. Potential plans include integrating a boutique hotel into the shopping center. This would further establish the Promenade as not just a first class retail and entertainment center, but as a destination for tourists that could accommodate all of

Baltimore

WORKING TOGETHER TO CREATE A BETTER FUTURE FOR OUR REGION: BALTIMORE REGION SUSTAINABLE DEVELOPMENT

Since March, program speakers addressed three (3) dimensions of the Opportunity Collaborative (OC), opportunity collaborative.org (http://opportunitycollaborative.org). Beginning with Michael B. Kelly, General Counsel and Government Relations at Baltimore Metropolitan Council (BMC), members learned the OC was funded in 2010 by a \$3.5 million Sustainable Communities Regional Planning Grant from the US Department of Housing and Urban Development (HUD) through BMC. This was one of sixty grants awarded from a field of 300 applications.

Coordinated and staffed by the BMC, the OC is a coalition of local governments, state agencies and non-profit organizations in the Baltimore Region. Activities underway as part of the Plan, to be produced and submitted to HUD in 2015, include development of a comprehensive analysis of the housing market including an analysis of impediments to fair housing choice (Fair Housing Equity Assessment/FHEA); a cross cutting strategy to connect the region's workforce to family supporting employment opportunities; and an integrated transportation system with coordinated economic development. In 2011, in concert with HUD's vision of livability, protection of the Chesapeake Bay was added. Storm water management practices to protect the Bay will be required.
